Wenatchee Kennel Club (WKC) is an AKC All Breed Club.

We promote the advancement of all dogs in our area with activities such as:

- Conformation Shows, Obedience and Rally Trials, Tracking Tests and Agility Trials under the rules of the American Kennel Club, Inc.
- Training Classes, Educational Events and Meetings for the betterment of our dogs and humans.
- Exhibitions, matches and a program of awards which will encourage sports competition and advance the interests of dogs.

Owning an AKC registered dog is not a requirement to join. We do ask that all members volunteer throughout the year at events or by serving on a committee, as much as they are able. Our club is a very relaxed group and we welcome all potential members.

Regular membership meetings are *usually* held on the last Sunday of every month at 7pm at the WKC Training Center located at 100 First Street in East Wenatchee. Once our Board of Directors has approved your completed application, your application will be presented at the next general membership meeting for a final vote of approval. You are welcome to attend any meeting at any point in the process. We'd love to meet you!
