ENTRIES CLOSE: Thursday, March 7, 2024 @ 5:00 PM., after which time entries cannot be accepted.

ENTRY LIMIT: TEST LIMITED TO SIX TD ENTRIES AND THREE TDX ENTRIES. AKC Tracking Regulations **Combined Tests Exchange Policy - Chapter 1 - Section 17a.**

Test Worker Option - Chapter 1 - Section 17d. Three (3) tracks may be set aside for test workers from previous tests

ENTRY FEE: TD = \$65.00, TDX=\$100.00 (includes the \$0.50 AKC recording fee and a \$3.00 Event Service Fee) for each dog. Fees must accompany all entries. Fees must be paid in **US FUNDS**.

An original Certification must accompany all TD entries.

ELIGIBILITY/CERTIFICATION: (TD ENTRIES) With each TD test entry of a dog that has not passed an AKC tracking test, there must be filed an original statement dated within two years, signed by a person who has been approved by the AKC to judge a tracking test, certifying that the dog is considered to be ready for such a test. (AKC Tracking Regulations Chapter 3 - Sec 2. Certifications)

ELIGIBILITY FOR TDX TEST: The Tracking Dog Excellent is for dogs that have passed an AKC Tracking test.

ALL ENTRIES will be accepted until the official closing date, even though the advertised limit has been reached. A drawing will be held on Thursday, March 7, 2024 at 5:30 p.m. at the WKC building. The drawing shall be completely random among all entries received, except that preference will be given to those dogs that have not previously earned a TD or TDX title. When the advertised limit has been drawn, all remaining entries, subject to the same preferences set forth above, shall be assigned a position on an alternate list. The alternates will be asked to be alternates who agree to be at the test site in case of absent dogs. Alternates not used will receive full refund of entry fees.

WENATCHEE KENNEL CLUB will also refund entry fees to any confirmed entry that withdraws from the test, provided the Test Secretary is notified prior to the day of the test and provided that an alternate entry participates in the test as a result of the withdrawal. If the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged up to a maximum of twelve TD's or six TDX.

BITCHES IN SEASON: Subject to the provisions set forth in the most current AKC Tracking Regulations. Bitches in season may participate. Entrants must notify the Test Secretary prior to the drawing for tracks. Please check with the secretary about where to park.

ACKNOWLEDGMENTS: Acknowledgments will be emailed by the Test Secretary after the closing of entries. Should the exhibitor not receive such an acknowledgment within reasonable time, please notify the Test Secretary at 406.249.5242 or via e-mail at: heatherstiver@gmail.com

TRACKING COVER: TD will be sagebrush and native cover, or hay fields and pasture. TDX may use all of the above plus orchards, Douglas Creek, and fences, if used, will be barbed wire.

DRAW FOR TD and TDX TRACKS: Draw for the running order of the TD and TDX tracks will be held on Sunday, March 17, at 8:00 AM. The first track will be run as soon as it's aged the appropriate time. In the event of any absentees among the confirmed entries, the next alternate, in catalog order, who is present, will be allowed to fill the vacancy.

Wooden Apple Plaques will be given to all dogs passing a TD or TDX test.



Those handlers and dogs marked "Passed" by the judges will be given the final article signed by judges.

ATTENTION EXHIBITORS

All dogs **MUST** be on a leash at all times per AKC Tracking Regulations.

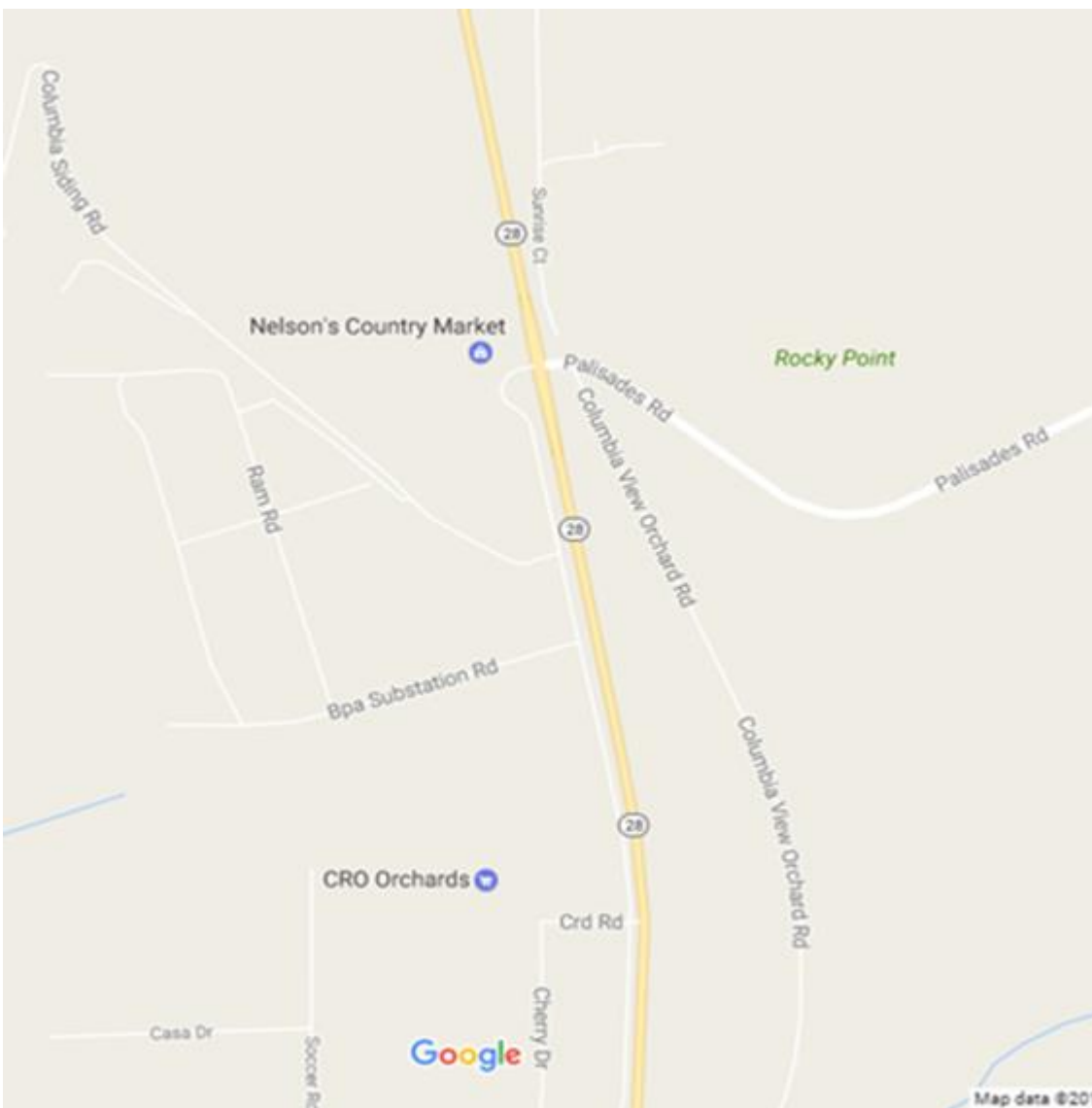
DIRECTIONS TO THE DRAW

The Draw will take place in the parking lot of **Country Market**, located at the intersection of Hwy 28 and the Palisades Road, halfway between East Wenatchee and Quincy.

From East Wenatchee stoplight at Grant Road and Hwy 28 (Fred Meyer), go east toward Quincy, 14.4 miles. Between mile marker 14 and 15 is beginning of road to Palisades.

Coming West from Quincy it is approximately 15 plus miles. Mile markers on left side of road.
